Residential, commercial and industrial property management services for individuals, families, funds, trusts, and a variety of public/private equity groups.

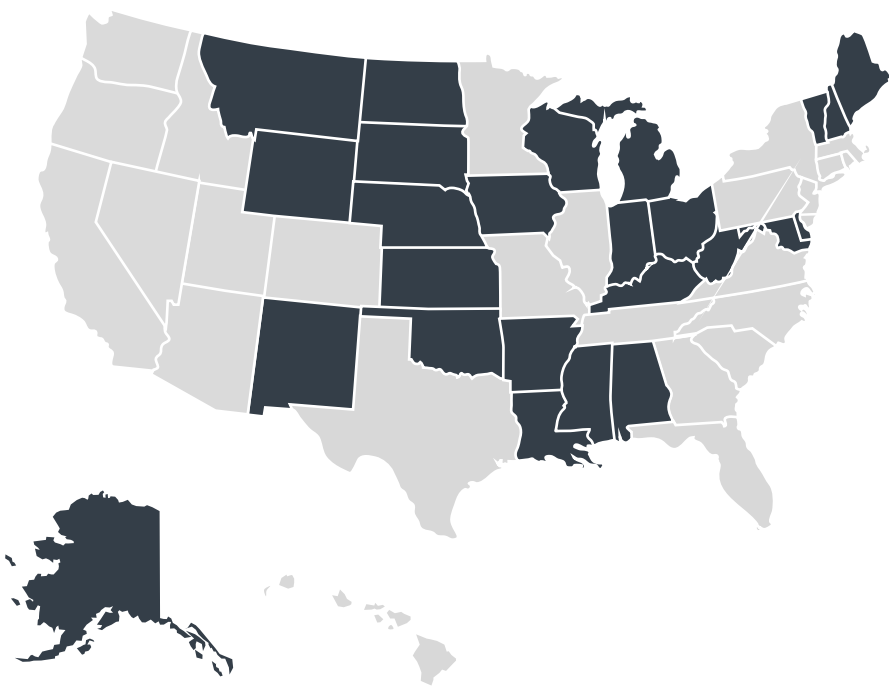
